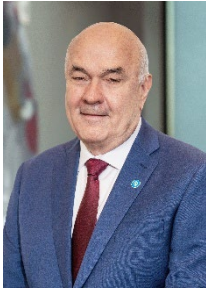

After holding senior leadership roles in the forestry industry, Pierre transitioned to the cooperative sector, serving as General Manager of the Caisses populaires of Mattice and Kapuskasing, and later as President and CEO of L'Alliance des caisses populaires de l'Ontario.

Pierre subsequently led two of the most significant co-operative initiatives in the history of this group: the simultaneous merger of 12 caisses populaires to form Caisse populaire Alliance limitée. Following the merger, he also oversaw one of the largest IT conversion projects undertaken by a credit union, successfully transitioning all systems - including core banking, online member services, loan origination systems (LOS) and back-office platforms - within a 72-hour window.

Pierre is chairperson of the board of directors of Groupe InnovaNor, a not-for-profit organization providing work integrated learning opportunities through its network of employers. In addition, he serves on several boards of directors including the Board of Governors of the University of Hearst and of the board of directors of Impact ON. He also contributed to the creation of the Co-op grocery store in Moonbeam, Ontario.

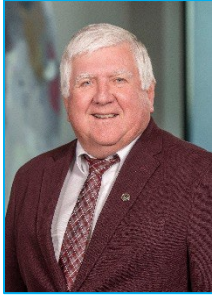
