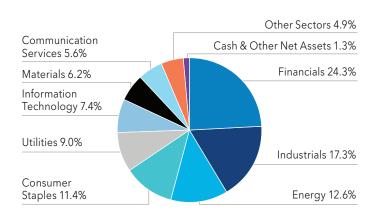

# **Investor Profile**

Suited to investors seeking mainly long-term capital appreciation by investing in a diversified portfolio of Canadian equities and with a long-term investment horizon. Investors should be able to accept a moderate level of risk.

#### **Investment Objective**

To achieve long-term capital appreciation by investing primarily in a diversified portfolio of mid-to-large-capitalization Canadian equities.

## **Investment Strategy**

The fund intends to achieve its objective by following the portfolio advisors' "growth at a reasonable price" investment style in selecting investments for the fund's portfolio. While it is required that the majority of investment be within Canada, the fund may invest up to 30% of its assets in the equity securities of foreign issuers.

The fund may hold a portion of its assets in cash, money market securities, or money market mutual funds while seeking investment opportunities, for defensive purposes, or for liquidity purposes. The fund may also engage in securities lending, repurchase and reverse repurchase transactions, as well as derivatives for hedging and non-hedging purposes.
