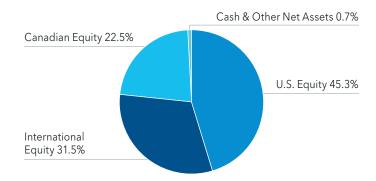
# **Co-operators MFS LifePlan Retirement 2065 Fund**

## **Investor Profile**

Suited to investors seeking an actively managed portfolio of fixed income and equity investments who have an anticipated retirement date in or around the year 2065. Investors should be able to accept a moderate level of risk.

### **Investment Objective**

To seek total return through a combination of current income and capital appreciation.

#### Investment Strategy

The fund intends to achieve its objective by investing primarily in a well-diversified Underlying Fund which subsequently invests in other underlying pooled funds offered by MFS Investment Management Canada Limited.

The fund's asset mix will change monthly based upon a prescribed schedule. Over time, the risk profile of the fund will change to a less volatile asset mix. In the stated target year (2065), the fund's asset mix will be aligned with the asset mix of the Co-operators MFS LifePlan Retiree Fund. It is expected that the fund will be merged with the Co-operators MFS LifePlan Retiree Fund within five years of the date that its asset mix matches the asset mix of the Co-operators MFS LifePlan Retiree Fund.

Permitted equity investments include common stock, preferred stock, shares, convertible securities, preference shares, depository receipts, share warrants, REITs, and all other securities deemed by the portfolio manager to be of an equity nature. Fixed income debt instruments include, but are not limited to, corporate, government, and mortgagebacked securities; structured debt including asset backed and commercial mortgage backed securities; emerging markets debt; high yield debt; bank loans, loan participations and assignments.

The fund's currency exposure may be hedged utilizing currency derivatives (e.g. options on currency, futures, and forward contracts).
