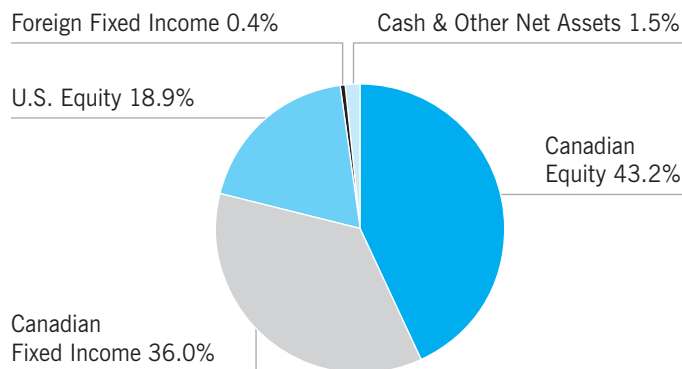


# Co-operators Aggressive Balanced Fund
